Trial Experience Highlights

Conducted month-long jury trial on 101 counts of drug distribution, health care fraud, and money laundering that resulted in conviction on all counts. Actively investigated case alongside federal and state agents, briefed and argued key legal issues before and during trial, conducted voir dire, delivered opening statement, drafted closing statement, conducted direct examinations of approximately three dozen witnesses, directed and cross examined financial experts.
